

## How do we help?

- We provide emotional support and recognise that a child's serious illness affects every family member differently. The support we offer is tailored to the needs of the individual.
- We also facilitate peer groups so that families can meet others in similar circumstances. This is vital in helping to reduce the fear and isolation felt by so many.
- We provide practical help such as transportation to and from hospital for an immune suppressed child and their family.
- We also provide sibling days so that Mum and Dad can get a rest whilst the child's brother or sister can talk to others in the same situation.
- For bereaved families we never set a limit. Families can continue to come to The Bluebells and can continue to use our services for as long as they need. We are always here and we always remember our 'butterfly children' and their special families.

### Do you know...

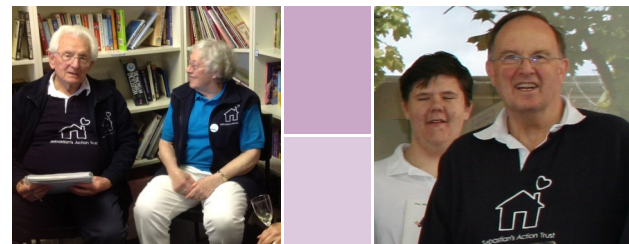

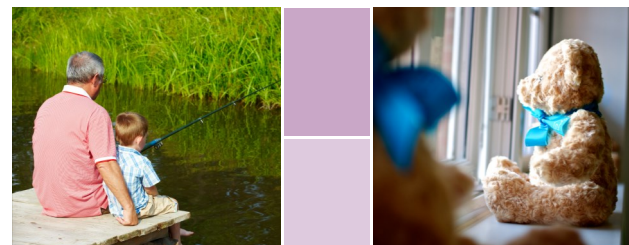
a light reflecting wall which remembers our special friends and those who have supported our charity throughout the years.
